The **2nd prize** was granted to **Alexis Saveriades** of Nicosia, Cyprus, for his photograph titled "Egg Anatomy".




The **3rd prize** was granted jointly to **Charis Ioannou** of Nicosia, Cyprus, for his photograph titled, "Day Dream" and

- Maria Savvidou of Nicosia, Cyprus, for the photograph "Unguarded Arms",


